1. From the ANZCTR Manager

2. ANZCTR milestones in 2015

There were several important milestones that occurred during 2015 including:

Over 10,000 trials registered!

This year the 10,000th trial was registered on ANZCTR, which was a significant milestone. At the time of writing there were a total number of 11,393 registered studies.

The ANZCTR turned 10!

In July 2015, the ANZCTR celebrated its 10th birthday. Since its establishment in 2005, the ANZCTR has become firmly entrenched as an integral part of Australia's research infrastructure.

New ANZCTR website

The ANZCTR team was very excited to launch its new-look website in October 2015. As well as a new logo and aesthetic improvements, a number of new enhancements have been added to the website's functionality including:

- o new intuitive website controls (pop-ups, help text, auto complete)
- more specific location data now collected 0
- ability for users to download multiple trials in 0 XML format
- improved search functionality
- ability to add attachments to registration 0 records
- o automatic update reminder emails
- o upgraded web server
- provisional registration marking for trials that 0 have not yet received ethics approval
- "Not up to date" status for records that have 0 not been updated in the last 12 months

Australian Clinical Trials website

The ANZCTR staff have been pleased to provide trial information data and support to the NHMRC's new Australian Clinical Trials website, which was launched In May 2015. See www.australianclinicaltrials.gov.au

Australian Cancer Trials website

Throughout 2015 the ANZCTR was pleased to continue its involvement and support of the Australian consumer-friendly Cancer Trials website www.australiancancertrials.gov.au. The data included on this website is sourced from both the ANZCTR and ClinicalTrials.gov, with ANZCTR staff being the main point of contact for enquiries from researchers and consumers.

Conference participation

2015 has been a busy year for ANZCTR staff, who have been working on a number of research projects using ANZCTR data. Staff presented the results of several of these projects at the Cochrane Colloquium in Vienna, the EQUATOR conference in Edinburgh, the ACTA Symposium in Sydney, and at the Sydney China Business Forum in Sydney.

3. WHO International Clinical Trial Registry Platform (ICTRP) - ongoing interactions

The ANZCTR continued its association with the WHO ICTRP in 2015 as a Primary Registry in the WHO Registry Network.


Data provider for the ICTRP Search Portal

As in previous years, the ANZCTR continues to provide an updated version of the registry's data to the WHO ICTRP each week.

The ICTRP Search Portal now lists data from 15 Primary Registries around the world plus ClinicalTrials.gov.

Throughout 2015 the ANZCTR registered an average of 115 trials per month - an increase from the 2014 average of 111 per month.


